Tax-Deductible Gifts

USA

Tax-deductible contributions may be made to Americans for Oxford, Inc. This organization can receive contributions and make grants available to Balliol College. Americans for Oxford, Inc. disburses funds quarterly to the College. Under U.S. Internal Revenue Service guidelines, the estimated value of any benefits received in acknowledgement of contributions to this mailing is not substantial; therefore the full amount of the gift is a deductible contribution.

The administration of gifts

Americans for Oxford, Inc. has been determined by the U.S. Internal Revenue Service to qualify under Sections 501(c)(3) and 509(a) of the Internal Revenue Code as a tax-exempt public charity.

To maintain the deductible status of gifts, U.S. law requires that the Board of Directors retains control and discretion concerning grants to Oxford. Although gifts to this organization must be unrestricted, the Board of Directors will certainly consider specific preferences of donors.

Corporate matching gifts

Americans for Oxford, Inc. can accept all tax-deductible contributions from corporate matching gift programs.

Privacy Notice

How we use your data

The personal data you provided on this form will be used by Balliol College to process your donation in accordance with our contractual and legal obligations, and to meet our legitimate interest of alumni and supporter engagement, fundraising and stewardship. We will use your data to: record information about your giving, including any gift agreements, memberships, or correspondence relevant to your donation; communicate with you about the impact of your donation and other appeals that may be of interest to you; record your updated contact details and mailing preferences; record your preferences regarding the external reporting of your donation; and record information about your willingness and capacity to support our charitable objectives, which may be provided by you or from information in the public domain.

Who has access to your data

The data you provided will be stored and shared across the collegiate University of Oxford, including with its relevant clubs and societies if appropriate, in accordance with the University's policies and procedures via our shared relationship management system. You have the right to object to the processing of your personal data at any time. The University and participating colleges are both "data controllers", meaning you can contact either the University or your college if you have questions about your data. We may also need to share it with third parties supporting the processing of your transaction. We will only do this in appropriate circumstances, for specified purposes, by secure means, using the minimum amount necessary, and with the relevant data sharing agreements in place. We do not and will not sell your data.

How long we keep your data

We consider our relationship with our donors, supporters and alumni to be lifelong and we will retain most of your data indefinitely unless you request otherwise.
